OFFICE MEMORANDUM

Subject : Amended scheme of 'Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons (PDUNWFS)'.

The undersigned is directed to refer to the Scheme of Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons (PDUNWFS), which was last revised on 22.09.2017 and to say that the scheme of PDUNWFS has been further amended.

2. In the amended scheme, the applications seeking assistance from the Fund will be disposed of in a time bound manner. All efforts would be made by the Ministry to dispose of the application within 45 (forty five) working days of the receipt of the application under the scheme. On receipt of application, Ministry will examine the application on eligible criteria and will forward the proposal to Sports Authority of India (SAI). SAI will depute an official to visit the applicant and give its report along with evidence/ photographs. SAI official will also obtain details with regard to bank name, bank account number, AADHAR Number, Income Tax, PAN etc.
3. A copy of the Scheme of **Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons (PDUNWFS)** amended as on 29th January, 2019 along with the proforma for application for financial assistance is enclosed.
4. It is requested that scheme of PDUNWFS may be given wide publicity and also be uploaded on websites of Sports Authority of India (SAI), Indian Olympic Association (IOA), National Sports Federation (NSFs), Sports Departments of State Governments/UTs.
